***SPECIAL CONDITION:** MS State Law requires that male applicants between the ages of eighteen (18) and twenty-six (26) submit satisfactory documentation of their compliance with the draft registration requirements of the Military Selective Service Act with application. In addition, males between the ages of eighteen (18) and twenty-six (26) who are currently employed shall not be promoted to higher positions until they submit documentation of compliance with the requirements of the Federal Selective Service Act.*

MINIMUM QUALIFICATIONS: ****EMPLOYEES IN THESE POSITIONS WILL UNDERGO AN EXTENSIVE BACKGROUND CHECK AS WELL AS RANDOM DRUG TESTING. THE DATA MAY BE USED AS PART OF A REVIEW PROCESS TO EVALUATE ELIGIBILITY FOR CONTINUED EMPLOYMENT.***

1. High school graduate or GED equivalent.
2. Must be at least twenty-one (21) years of age.
3. Twelve (12) months full-time paid experience in physical security, general security, or law enforcement.
4. Must be able to obtain a favorable National Agency Check (NAC).
5. Possess a valid driver's license and if authorized to operate a government vehicle, must have the ability to obtain and maintain U.S. Government Motor Vehicle Operators ID card. **PROOF OF DRIVER'S LICENSE MUST BE SUBMITTED WITH APPLICATION.**
6. Knowledge of basic first aid, fire prevention, safety and radio communications procedures.
7. Must attend and satisfactorily complete any military/civilian training/schooling that may be required.
8. Must be able to physically able to perform all duties.
9. Never been convicted of a felony.
10. Must attend and satisfactorily complete all requirements to become certified as a Law Enforcement Officer in the State of Mississippi within 12 months of hire.
11. Must pass a physical agility test comprising pushups, agility run and 1 ½ mile run within state law enforcement officer standards.
12. Must be able to physically perform all duties.

DUTIES AND RESPONSIBILITIES: (Not all inclusive, will be fully explained during interview)

1. Performs Law Enforcement duties within the boundaries of Camp Shelby Joint Forces Training Site.
2. Insures compliance with Resource Protection Plans.
3. Monitors the control entry and exit of personnel, vehicles, and equipment through entry points to facilities and parking areas.
4. Prepares variety of job-related reports and documentations.
5. Operates communication equipment.
6. Provides emergency response and assumes responsibility for situations until key personnel are notified and is relieved by higher authority.
7. Provides Law Enforcement support to visitor and crowd control on a routine and emergency basis.
8. Conducts searches of persons, vehicles, and property within jurisdictional limitations and in accordance with governing directives.
9. Apprehends suspects who have violated applicable regulations and policies and provide for their detention relieved by higher authority.
10. Performs other duties as assigned.
