***SPECIAL CONDITION: MS State Law requires that male applicants between the ages of eighteen (18) and twenty-six (26) submit satisfactory documentation of their compliance with the draft registration requirements of the Military Selective Service Act with application. In addition, males between the ages of eighteen (18) and twenty-six (26) who are currently employed shall not be promoted to higher positions until they submit documentation of compliance with the requirements of the Federal Selective Service Act.***

**MINIMUM QUALIFICATIONS: \*EMPLOYEES IN THESE POSITIONS WILL UNDERGO AN EXTENSIVE BACKGROUND CHECK AS WELL AS RANDOM DRUG TESTING. THE DATA MAY BE USED AS PART OF A REVIEW PROCESS TO EVALUATE ELIGIBILITY FOR CONTINUED EMPLOYMENT.**

1. High school graduate or GED equivalent.
2. Must be at least twenty-one (21) years of age.
3. Must have a minimum of twelve (12) consecutive months full-time paid experience in physical security, general security, or law enforcement.
4. Must be able to obtain a favorable National Agency Check (NAC).
5. Possess a valid driver's license and if authorized to operate a government vehicle, must have the ability to obtain and maintain U.S. Government Motor Vehicle Operators ID card. **PROOF OF DRIVER'S LICENSE MUST BE SUBMITTED WITH APPLICATION.**
6. Qualify annually with primary weapon.
7. Must attend and satisfactorily complete any military/civilian training/schooling that may be required.
8. Never been convicted of a felony.
9. Military membership is desired; but not required.

**DUTIES AND RESPONSIBILITIES: (Not all inclusive, will be fully explained during interview)**

1. Provide physical security, visual observation, provide information and direct visitors and other personnel to their destination.
2. Monitors electronic alarm systems and maintains a record of activity.
3. Prepares incident reports and detains/arrest suspects until proper authorities arrive.
4. Operates two-way radio and fixed communications equipment.
5. Control access to Camp McCain Training Center.
6. Patrol Camp McCain Training Center to ensure that the area is physically secure and free of unauthorized personnel.
7. Execute Standard Operating Emergency Procedures and maintain a written record of security protection activities.
8. Performs other duties as assigned.
