A. ISSUE A GENERAL ORDER EFFECTING RELEASE OF UNITS ACCORDANCE WITH PARAGRAPH 9\ AR 130-22.

B. PROCESS AND RELIEVE FROM ACTIVE MILITARY SERVICE THE UNITED STATES\ UNITS AND INDIVIDUALS OF THE ARMY NATIONAL GUARD OF THE STATE OF MISSISSIPPI AT HOME STATIONS.

C. DESIGNATE THE UNITS AND/OR ACTIVITIES THAT WILL ACCOMPLISH RELEASE PROCESSING. THE GENERAL ADMINISTRATIVE\ MEDICAL\ FINANCIAL SUPPORT AVAILABLE AT THE INSTALLATIONS WITHIN THE GEOGRAPHIC AREA OF THE THIRDS US ARMY WILL BE UTILIZED AS NECESSARY TO ASSIST IN RELEASE PROCESSING.
