

BRIGADIER GENERAL GREGORY L. KENNEDY

Assistant Adjutant General – Army, Mississippi



Brigadier General Gregory L. Kennedy was appointed Assistant Adjutant General – Army, on September 1, 2016. As the Assistant Adjutant General, he guides the formulation, development and implementation of all programs and policies affecting the Mississippi Army National Guard and its nearly 10,000 Citizen Soldiers.

General Kennedy was commissioned as a Second Lieutenant, Infantry, on December 17, 1982 through the Reserve Officers' Training Corps at the University of Mississippi where he was recognized as a Distinguished Military Graduate. He has served in command and staff positions at every level, including Commander, 1st Battalion, 185th Aviation Regiment, Commander, 185th Aviation Brigade, Deputy Chief of

Staff, State Aviation Officer, Joint Force Headquarters, Mississippi Army National Guard, Commander, 66th Troop Command, and Commander, 184th Sustainment Command. General Kennedy served on active duty as Brigade S3 Liaison Officer, 155th Armored Brigade Combat Team during combat operations in Operation Iraqi Freedom in 2009.
